

# CITY OF YELLOWKNIFE Adopted Council Minutes Regular Meeting Monday, March 13, 2000 at 7:00 p.m.

MEMBER STATEMENTS

8. Councillor Brooks congratulated the "Snowking" Tony Folliot on the work he has put into the development of the Snow Castle on Great Slave Lake in Old Town which has become a popular tourist attraction.

Councillor Brooks stated that he recently attended the Federation of Canadian Municipalities' Board of Directors Meeting. Topics for discussion included the physician and nursing crisis in remote municipalities; impact on northern and remote communities regarding aviation transportation; economic development; and lack of road infrastructure. While at the meeting, Councillor Brooks was elected Vice-Chair of the Northern Rural & Remote Caucus. Councillor Brooks will submit a full travel report to Committee.

9. Councillor Lyons stated that he recently attended the Arctic Winter Games in Whitehorse, YT and expressed thanks to all those who were involved with the Games. Councillor Lyons noted that he spoke to a number of business owners who all stressed the importance of tourism to their community.



- 10. Mayor Lovell stated that he recently attended the Prospectors and Developers Annual Conference. Mayor Lovell noted that the conference theme was continuous investment in mining exploration and that the conference was an extreme success. The Yellowknife booth was very popular and Mayor Lovell thanked the Economic Development Division for their assistance in this regard. Mayor Lovell noted that he will be submitting a complete travel report to Committee.
- 11. Councillor McDonald noted that Cindy MacDougall will be leaving Northern News Services and will now be working for CBC. Councillor McDonald stated that the coverage received from Ms. MacDougall has been fair and he bid her good wishes.

Public Services Committee Report for March 7, 2000

- 14. Councillor Best read a report of a meeting held on Tuesday, March 7, 2000 at 9:00 a.m. in the City Hall lower boardroom. The attendance was noted.

That the parking restrictions on Franklin Avenue from  $47^{\text{th}}$  Street to  $54^{\text{th}}$  Street from 11:30 a.m. - 1:30 p.m. be removed and that parking restrictions from 3:00 a.m. - 9:00 a.m. and from 4:30 p.m. - 6:00 p.m. be continued.

Those in favour of the motion noted that they have received several positive responses from the public who are happy that they are able to park on Franklin Avenue during the lunch hour. Members stated that this helps to promote the downtown and has a positive effect on Council businesses. noted that alternatives such as an advanced turning light, a slower speed limit in the downtown and restricted parking on the corners could be reviewed to address safety concerns. Council also suggested that the City review the way in which traffic is moved noting that the majority of current traffic movements are single occupant vehicles.

Those opposed to the motion stated that the problem with traffic congestion on Franklin Avenue was identified and addressed a few years ago and at that time Council decided the best solution would be to go with four lanes of traffic which proved to be a viable solution.



The current study showed that the problem still exists and that permitting parking during the noon hour would be a step backwards and only transport traffic to the side streets.

# DELEGATIONS PERTAINING TO ITEMS NOT ON THE AGENDA

- 23. Council noted that Mr. Vaughan del Valle has requested to make a presentation regarding the new Zoning By-law. Mayor Lovell advised Mr. del Valle that Council is unable to hear his presentation on this matter until after the bylaw has received Third Reading. Council noted that there have been several opportunities for the public to provide input on the by-law and that there are other remedies, such as spot zoning, that Mr. del Valle may wish to pursue. Council noted that when the by-law is presented for Third Reading, any Member may put forward a motion to refer the issue back for a second public hearing.
- 24. Council heard a presentation from Mr. Jim Wiley, a resident who had worked at the Giant Mine for over 20 years. Mr. Wiley told Council that he has been advised that his pension from the Government will be reduced by 25% as his former employer, Royal Oak Giant Mine, underfunded the pension plan. Mr. Wiley stated that during contract negotiations dating as far back as 1978, the company assured the miners that the Government of Canada ensures that the company contributes the proper amounts to the pension fund. As a result of the pension cut, Mr.



Wiley and other pensioners are circulating a petition calling for the Government of Canada to reinstate their pensions and amend its legislation to ensure that this does not happen again in the future. As of this date there are over 1500 signatures on the petition.

25. Council heard a presentation from Mr. Don McNenley who retired from the Giant Mine last March after 32 years of service and whose pension has also been reduced. Mr. McNenly stated that he hopes that the pensions are reinstated, however, if they aren't successful, he would like to see the legislation changed. Mr. McNenley thanked the citizens who have helped with this petition.

# NEW BUSINESS

Council noted that the lease will restrict the use of the building to that of a youth centre.

That Council adopt the following resolution:

WHEREAS corporate underfunding (as allowed by the Federal *Pension Benefits Act*) of the pension plan for workers at Royal Oak Giant Mine in Yellowknife has resulted in a 25% cut to individual retirees' pensions; and

WHEREAS deficiencies in the Bankruptcy and Insolvency Act has meant that these same workers have received none of the severance pay to which they were entitled; and

WHEREAS a negotiated arrangement to which a Federal Government Department is party allowed these egregious wrongs to continue; and

WHEREAS the cuts to the pensions and severance payments for former Giant mine workers will adversely affect these individuals, their families and the community as a whole; and

WHEREAS Resolution #0311-99 of the Council of the City of Yellowknife, which was passed unanimously on September 9, 1999, called for the fair treatment of Giant Yellowknife workers as part of any agreement on the future of the property;

THEREFORE BE IT RESOLVED that the Council of the City of Yellowknife call upon the Government of Canada to:

 Ensure that all workers at Royal Oak Giant Yellowknife mine receive their full earned pension entitlement;

- Ensure that these workers receive all severance entitlements to which they were entitled;
- Amend the Pension Benefit Act and Bankruptcy and Insolvency Act to enshrine and give precedence to the protection of the rights and interests of Canadian workers.

Councillor O'Reilly provided Council with background information, noting that the 25% cutback is in addition to the 12% cut imposed by the Courts at the request of the company liquidator. In addition to the pension cutbacks, the workers of the Royal Oak Giant Yellowknife Mine have not received their severance pay for which they are entitled. Council noted that the pension cutbacks not only affect current retirees but that all retirees will lose 25%. It was suggested that this resolution be forwarded to the NWT Association of Municipalities and the Federation of Canadian Municipalities for their endorsement.
