Dear Mr. Stard:

Thank you for your letter dated April 11, 1996 regarding the public forum on arsenic in the Yellowknife area. I apologize for not being able to reply to your letter sooner. In the interest of brevity I have responded to your list of questions in point form below.

- A list of the confirmed panel members and their organizational affiliation is appended. I have noted the specific topics each has been asked to address in brackets.
- Each panellist is being asked to speak for 5 minutes. The topic we would like a Royal Oak representative to address would be how the mine currently handles the arsenic it produces as a byproduct of its gold mining operation at the Giant Yellowknife mine.
- We have not invited a representative from Con mine as it is our understanding that this mine has a system for handling arsenic that basically removes any concerns for environmental contamination. Your suggestion of a representative from either Con or the Chamber of Mines is a good one. However, as our panel is already at 6 members, I see a need to keep it from growing too unwieldy.
- I am not aware of any new information that you should be aware of on this subject.
